

ARTICLES OF ORGANIZATION OF 3 D Mechanical, LLC

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under the Alabama Code Sections 10-12-1 to 10-12-61, do hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

3 D Mechanical, LLC

SECOND: The Limited Liability Company shall continue until the occurrence of an event set forth in the Operating Agreement which causes the termination of the Limited Liability Company.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Alabama Code Sections 10-12-1 to 10-12-61, including all powers and purposes now and hereafter permitted by law to a limited liability company.

SIXTH: The Limited Liability Company will be operated by the Members, and no manager will be appointed. SEVENTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members, in accordance with the terms and conditions of the Operating Agreement of the Limited Liability Company.

EIGHTH: The remaining Members of the Limited Liability Company, by the unanimous vote or consent of the Members (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.
