(herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto

REGINALD G. HURST AND STEPHANIE R. HURST, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE HURST LIVING TRUST, DATED NOVEMBER 30, 2005 AND ANY AMENDMENTS THERETO

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 25, according to the Survey of Spring Gate Estates, Phase Two, as recorded in Map Book 20, page 120, in the Probate Office of Shelby County, Alabama. Subject to taxes, restrictions, rights-of-way, exceptions, conditions, covenants and easements of record.
