That certain deed recorded in Inst# 1995-32497 incorrectly named the Grantee as Venture Development, whereas should have correctly named the Grantee as Venture Development, LLC.

That the purpose of this affidavit is to correct the Probate Records of Shelby County, Alabama, and specifically, to correct the named Grantees therein of those certain deeds, which were recorded in Inst# 1998-44192 and Inst# 1995-34182 and Inst# 1995-32497, in the Probate Office of Shelby County, Alabama, and that the error made in the preparation of said deeds was not a contractual obligation between the sellers, Dorothy Marie Busby, Cheney Lime Company, a corporation, and George B. Juneman, J. B. Monzella, III, and F.F. & B. Enterprises, a Partnership, and the purchasers, Venture Development, Inc. and Venture Development, but merely an error on the part of the preparer.
