
AUCTIONEER'S DEED



STATE OF ALABAMA COUNTY OF SHELBY

WHEREAS, Brian T. Carpenter and Cristy M. WHEREAS, a sale has been made of the said real property hereinafter described during the legal hours of sale on the 8th day of December, 2005, at the front door of the Courthouse of Shelby County, Alabama, in strict conformity with the powers of sale contained in the said mortgage, at which sale **Countrywide Home Loans, Inc.** was the highest and best bidder and did become the purchaser of the real property hereinafter described for the sum of \$95,874.02 cash in hand paid by said purchaser to Michael T.
