KNOW ALL MEN BY THESE PRESENTS, THAT


Whereas, on the 6th day of April, 1992, a decree was rendered by the Probate Court of said county for the sale of the lands, hereinafter described, and conveyed for the state and county taxes then due from **David Paul Carden**, the owner of said land for the costs and expenses thereof and thereunder.
