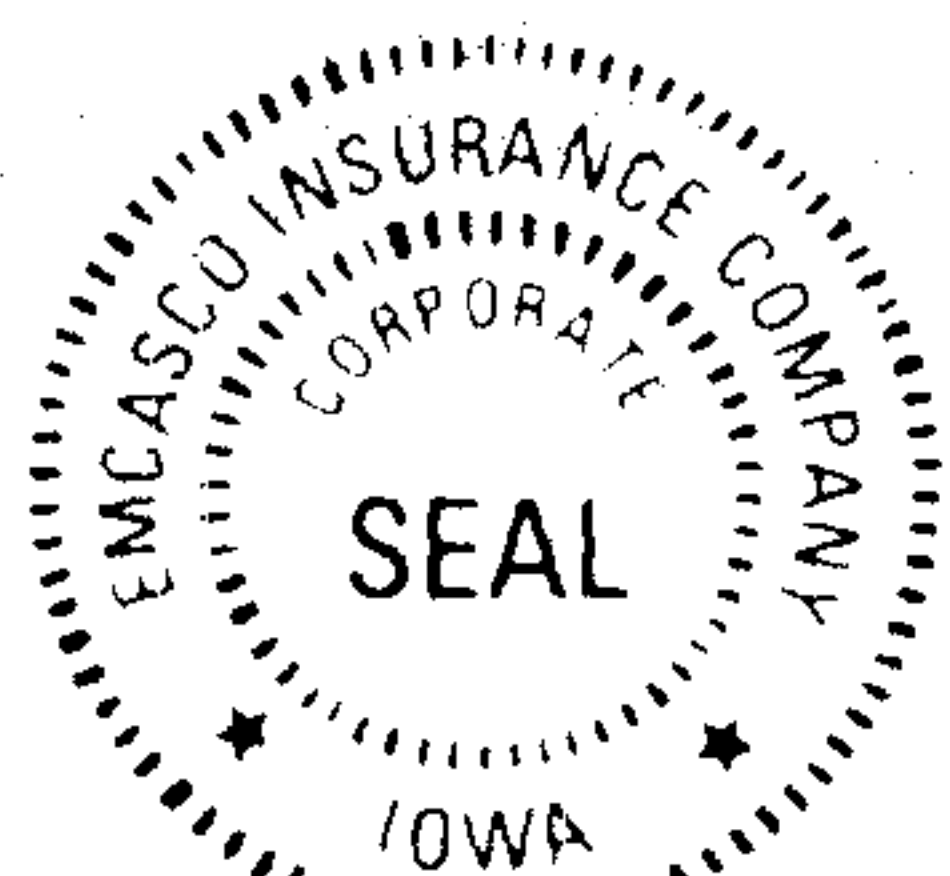
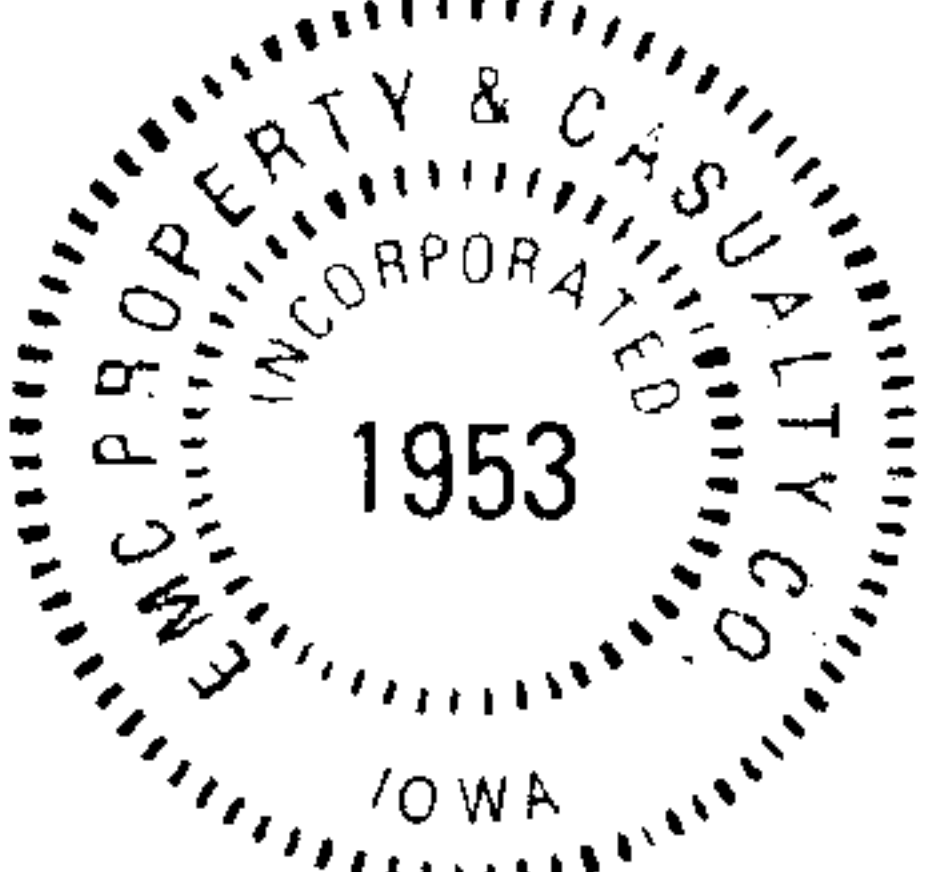
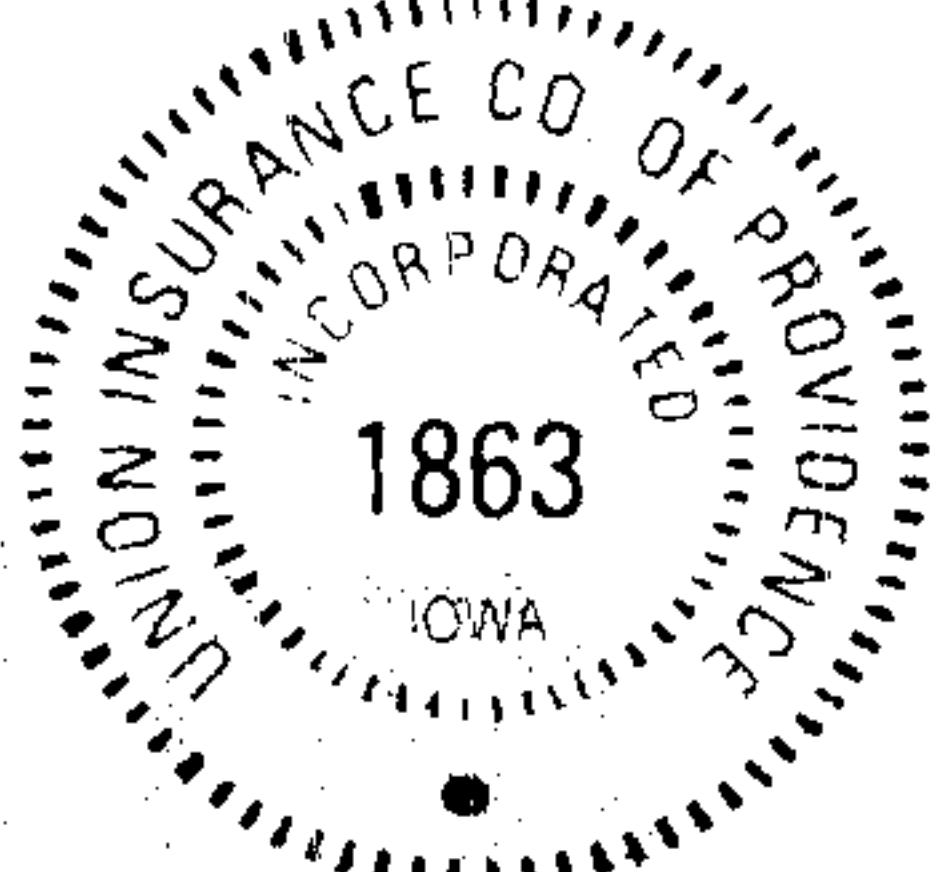
The authority hereby granted shall expire August 1, 2007 unless sooner revoked.**AUTHORITY FOR POWER OF ATTORNEY**
