1. The name of the Nonprofit Corporation is "Shelby County Shooting Sports Association, Inc".

2. The period of its duration is perpetual.

3. The purpose or purposes for which the corporation organized are: Educational and the promotion of the shooting sports in Alabama and related activities. It is expressly provided that the purposes and powers shall not be held to limit or restrict the powers of the corporation in any manner whatsoever otherwise granted by law, and the corporation shall transact any or all lawful business for which Nonprofit Corporations may be incorporated under the Alabama Nonprofit Corporation Act, Title 10-3A-1, Code of Alabama 1975..

4. No shares of stock shall be issued, but the Corporation may have an unlimited number of members.
