

AMENDMENT TO REAL ESTATE MORTGAGE AND SECURITY AGREEMENT

This Amendment (the "Amendment") is made and entered into on December 22, 2005, by and between CJ Builders, Inc. (hereinafter called the "Mortgagor", whether one or more) and First Commercial Bank (hereinafter called the "Mortgagee").

RECITALS

- A. CJ Builders, Inc (hereinafter called the "Borrower", whether one or more) has (have) entered into as agreement entitled "First Commercial Bank Real Estate Mortgage and Security Agreement", executed by the Borrower in favor of the Mortgagee dated July 13, 2005 (the "Credit Agreement"). This Credit Agreement is in the amount of Two Hundred Ninety-Six Thousand Two Hundred Fifty and Zero 00/100 Dollars (\$296,250.00).
- B. The Mortgagor has executed in favor of the Mortgagee a Real Estate Mortgage and Security Agreement (the "Mortgage") recorded July 26, 2005 in Inst.# 20050726000375150, in the Probate Office of Shelby County, Alabama.
- C. The Borrower and the Mortgagor have requested that the Mortgagee increase the Mortgage amount to Three Hundred Sixteen Thousand and Zero 00/100 Dollars (\$316,000.00).
- D. The Mortgagee has required, as a condition to approving the request for the Amended Mortgage, that the Mortgagor enter into this Amendment.


Except as specifically amended hereby, the Mortgage shall remain in full force and effect in accordance with its terms.
