KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on July 7, 2003, **Timothy M Daw and Angelia Daw, individually and husband and wife, Party of the First Part**, executed a certain mortgage to **Aliant Mortgage Corporation**, which said mortgage is recorded in Real Property Book 2003, Page 43473, and re-recorded in Real Property Book 2003, Page 52752, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to SunTrust Mortgage, Inc. on July 9th 2003, in Book 2003 Page 52573; and

WHEREAS, on January 5, 2006, the day on which the foreclosure sale was due to be held under the terms of said notice, during the legal hours of sale, said foreclosure was duly and properly conducted and the person conducting the sale on behalf of the mortgagee did offer for sale and sell a public outcry, in front of the main entrance of the Courthouse, Shelby County, Alabama, the property hereinafter described; and
