## REDEMPTION DEED FROM THE NORTH SHELBY COUNTY FIRE and EMERGENCY MEDICAL DISTRICT

SHELBY COUNTY STATE OF ALABAMA KNOW ALL MEN BY THESE PRESENTS, THAT

WHEREAS, the property hereinafter described, in the North Shelby County Fire and Emergency Medical District of Shelby County, Alabama was on the Twelfth (12<sup>th</sup>) day of July, 2004 sold by the President of the Trustees of the North Shelby County Fire and Emergency Medical District for the payment of certain assessments for fire prevention and emergency medical services and charges, and

WHEREAS, the North Shelby County Fire and Emergency Medical District purchased said property at said sale for the sum of One Thousand Four Hundred Fourty Six and 67/100 dollars (\$1,446.67) all of which more specifically appears by that certain deed executed by J. E. Wyatt as President of the Trustees of the North Shelby County Fire and Emergency Medical District, and


