LEASE TERMINATION AGREEMENT

This Lease Termination Agreement is entered into on September 28, 2005, by and among The Alabama Public Health Care Authority, a public corporation of the State of Alabama (the "Authority"), the Alabama Department of Public Health, an agency of the State of Alabama (the "Department"), and Wachovia Bank, National Association, a national banking association (the "Trustee").

Recitals

The Authority and the Department have heretofore entered into a Lease Agreement dated as of May 1, 1996 ("the 1996 Lease"), pursuant to which the Authority leased certain public health facilities to the Department. The said facilities were financed by \$30,000,000 aggregate principal amount of Mortgage Revenue Bonds, Series 1996 (the "Series 1996 Bonds") issued by the Authority. The Authority assigned its interest in the 1996 Lease to the Trustee pursuant to a Mortgage and Trust Indenture dated as of May 1, 1996 (the "1996 Indenture"), between the Authority and SouthTrust Bank of Alabama, National Association (predecessor to the Trustee). The 1996 Lease was recorded as indicated on Appendix A attached hereto.

The Authority and the Department have now arranged for the Series 1996 Bonds to be fully paid within the meaning of the 1996 Indenture and the Trustee has satisfied and discharged the Indenture.

WHEREFORE, pursuant to the provisions of the 1996 Lease, including particularly Section 11.2 thereof, the parties to this Lease Termination Agreement hereby acknowledge that the 1996 Lease is hereby terminated in all respects.

IN WITNESS WHEREOF, the Authority, the Department and the Trustee have caused this Lease Termination Agreement to be executed by their duly authorized representatives, this the 28th day of September, 2005.
