KNOW ALL MEN BY THESE PRESENTS,

That in consideration of **ONE DOLLAR (\$1.00)** and other good and valuable considerations to the undersigned grantor, in hand paid by the grantees herein, the receipt whereof is hereby acknowledged, I, **Virginia P. Minor, a widow**, (herein referred to as grantor), do grant, bargain, sell and convey unto **Marie M. Lasher** and **Maureen M. Mayfield**, (herein referred to as grantees), as tenants in common, all of my undivided interest in and to the following described real estate situated in Shelby County, Alabama, to-wit:

PARCEL 4:

The Northwest Quarter of the Southeast Quarter of Section 34, Township 21 South, Range 1 East, being situated in Shelby County, Alabama.

LESS AND EXCEPT:

A part of the NW 1/4 of SE 1/4 of Section 34, Township 21 South, Range 1 East, more particularly described as follows: Commence at the NW corner of said Quarter-Quarter Section and run thence in a Southerly direction along the Westerly boundary of said Quarter-Quarter Section a distance of 246 feet to a point; thence turn to the left an angle of 90 deg. and run in an Easterly direction a distance of 256 feet to the point of beginning of the property herein excepted; thence continue in the same direction a distance of 157.5 feet to a point; thence turn to the right an angle of 90 deg. and run in a Southerly direction a distance of 280 feet to a point; thence turn an angle of 90 deg. to the right and run a distance of 157.5 feet to a point; thence turn to the right and run a distance of 280 feet to the point of beginning. 


