KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of October 2004, Jason Michael Bryant, a single person, executed that certain mortgage on real property hereinafter described to National City Mortgage Co. dba Commonwealth United Mortgage Company, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. 
