THIS FORECLOSURE DEED made this 10th day of January, 2006, between JAMES T. ODOM and ELIZABETH ANN ODOM, husband and wife, Parties of the First Part, and GREEN TREE FINANCIAL CORP. N/K/A GREEN TREE – AL LLC, Party of the Second Part;

W I T N E S S E T H :

WHEREAS, the said JAMES T. ODOM and ELIZABETH ANN ODOM, husband and wife, heretofore executed to ADMIRAL FUNDING, LLC, herein called the Mortgagee, a certain mortgage dated September 30, 1997, and recorded in Instrument No. 1997-33964, Probate Records of Shelby County, Alabama, which conveyed the hereinafter described property to secure the indebtedness evidenced by a note, payable in installments, therein described; and

WHEREAS, the Mortgagee has granted, bargained, sold, conveyed and assigned the said mortgage and the indebtedness thereby secured and the property therein described to the Party of the Second Part, by assignment dated October 31, 1997, and recorded in Instrument No. 1999-31947, Probate Records of Shelby County, Alabama, and the Party of the Second Part was owner thereof at the time of the sale hereinafter mentioned; and

WHEREAS, the said mortgage provides that if said indebtedness or any part thereof should remain unpaid at maturity, then the whole of indebtedness shall at once become due and payable and said mortgage be subject to foreclosure, and further provides that in the event of any such default the Mortgagee shall have the authority to sell said property before the Courthouse Door in the City of Columbiana, County of Shelby, State of Alabama, at public outcry for cash after first giving notice by publication once a week for three successive weeks of the time, place and terms of said sale in some newspaper of general circulation published in Shelby County, Alabama, and further provides that in the event of any such sale the person conducting such sale shall have power and authority to execute a deed to the purchaser of said property at such sale, and further provides that the Mortgagee or its assigns may bid and become the purchaser at such sale of the property therein; and

WHEREAS, parts of said indebtedness remained unpaid at the respective maturities thereof, and the whole of said indebtedness thereupon became due and payable, and default was made in payment thereof, and the Party of the Second Part thereafter gave notice by publication in The Shelby County Reporter, a newspaper of general circulation and published in Shelby County, Alabama, on the 14th day of December, 2005, and the 21st day of December, 2005, and the 28th day of December, 2005, that it would sell the hereinafter described property before the front door of the Shelby County Courthouse at Columbiana, Alabama, at public outcry to the highest bidder for cash, within the legal hours of sale on the 10th day of January, 2006; and

WHEREAS, the said sale was held at the time and place stated in said notice which was published in the said issues of The Shelby County Reporter, and Party of the Second Part became the purchaser of the hereinafter described property at and for the sum of \$260,971.25 cash, which was the highest, best, and last bid therefore; and


