TO HAVE AND TO HOLD unto the Grantee, and the Grantee's successors and assigns, forever.


It is expressly understood and agreed that this General Warranty Deed is made subject to the following (the "Exceptions"):




Exhibit A

(Legal Description)

Commence at the Northwest corner of the NW ¼ of the SW ¼ of Section 16, Township 21 South, Range 2 West; thence run East along the North line of said ¼ ¼ section a distance of 99.05 feet to the East margin of a County gravel road and the point of beginning; thence continue along the north line of said ¼ ¼ section a distance of 1624.23 feet; thence turn an angle of 87° 32' 32.25" to the right and run a distance of 161.28 feet; thence turn an angle of 92° 27"23.75" to the right and run a distance of 1652.58 feet to the East margin of said County gravel road; thence turn an angle of 97°34"52" to the right and run along said road margin a distance of 162.55 feet to the point of beginning. Situated in the N ½ of the SW ¼ of Section 16, Township 21 South, Range 2 West, Huntsville Meridian, Shelby County, Alabama.
