

AMENDMENT TO CERTIFICATE OF INCORPORATION OF THE APOSTOLIC TRUTH CENTER, INC.


Come now the undersigned Trustees and file this Amendment to Certificate of Incorporation of The Apostolic Truth Center, Inc., pursuant to §§ 10-4-20 et seq., Code of Alabama 1975 as amended, and state as follows:

- I. The name of the corporation is the Apostolic Truth Center, Inc.
- II. The corporation was incorporated on February 29, 1996, and the Certificate of Incorporation was recorded as Instrument # 1996-07788 in the Probate Office of Shelby County, Alabama.
 - III. The Certificate of Incorporation is amended to add the following provisions as Section 6 thereof:
- "6. The purposes for which the corporation is organized are exclusively religious, charitable, and educational within the meaning of $\S 501(c)(3)$ of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law. Notwithstanding any other provisions of this certificate, this organization shall not carry on any activities not permitted to be carried on (a) by an organization exempt from Federal income tax under $\S 501(c)(3)$ of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law, or (b) by a corporation, contributions to which are deductible under $\S 170(c)(2)$ of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law.

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of § 501(c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the organization shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office."


