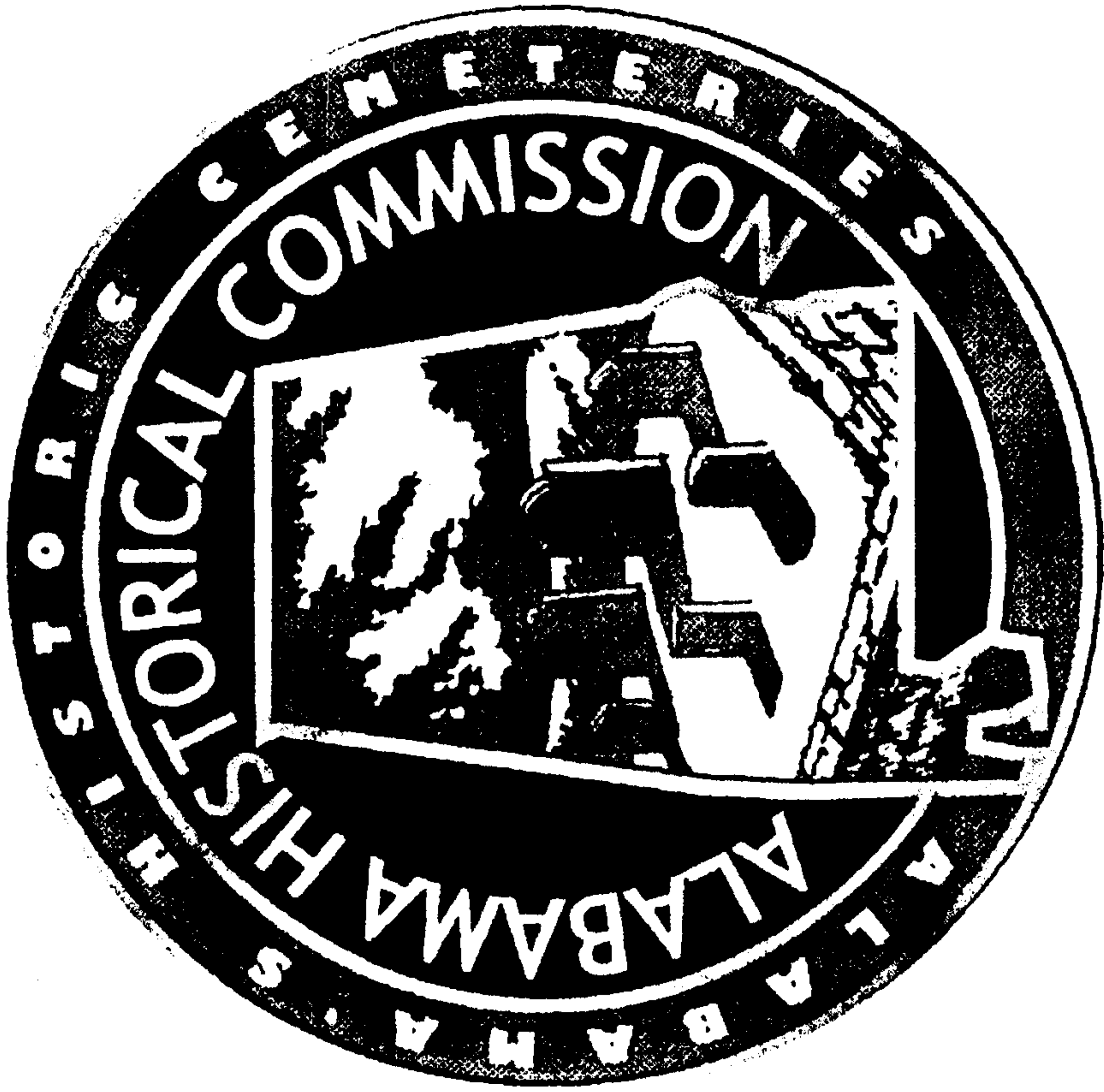

RECOGNIZING THE WILLIAM T. TINNEY FAMILY CEMETERY IN SHELBY COUNTY UPON BEING LISTED AS AN ALABAMA HISTORIC CEMETERY

WHEREAS, the William T. Tinney Family Cemetery located in Wilsonville in Shelby County has recently been listed on the Alabama Historic Cemetery Register by the Alabama Historical Commission; and

WHEREAS, the William T. Tinney Family Cemetery was first used by the Tinney Family for the burial of William T. Tinney in 1916; and

WHEREAS, William T. Tinney was born on January 15, 1845; he served in the Confederate Army and was wounded in battle; he married and moved to Wilsonville in Shelby County where he died on November 30, 1916; and

WHEREAS, the William T. Tinney Family Cemetery has continuously been used as a family cemetery since the burial of William T. Tinney; and

WHEREAS, the William T. Tinney Family Cemetery is located in the NW 1/4 of the NW 1/4 of Section 6, Township 21 South, Range 2 East and the NE 1/4 of the NE 1/4 of Section 1, Township 21 South, Range 1 East, Shelby County, City of Wilsonville; and

WHEREAS, the Alabama Legislature desires to further honor the historical significance of the William T. Tinney Family Cemetery in the history of our state; now therefore

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE LEGISLATURE OF ALABAMA, That the William T. Tinney Family Cemetery is recognized upon being listed on the Alabama Historic Cemetery Register by the Alabama Historical Commission and the Tinney Family descendants are commended on their efforts to preserve this important landmark in the history of our state.

BE IT FURTHER RESOLVED, That a copy of this resolution be forwarded to the William T. Tinney Family.
