KNOW ALL MEN BY THESE PRESENTS,

THAT IN CONSIDERATION OF One Hundred Twenty-Nine Thousand Five Hundred and No/100 Dollars (\$129,500.00) paid to the undersigned Grantor, in hand paid by the Grantee herein, the receipt of which is hereby acknowledged, **GNC, LLC**, an Alabama limited liability company (herein referred to as Grantor), does grant, bargain, sell and convey unto **JDS HOMES, INC.**, an Alabama limited liability company (herein referred to as Grantee), the following described real estate (herein referred to as the Property), situated in the State of Alabama, County of Shelby, to-wit:

LOTS 107, 108, 109, 110 and 111 according to the Survey of
Hidden Forest, as recorded in Map Book 35, Page 117, in the
Probate Office of Shelby County, Alabama.

The above recited consideration was paid by mortgage loans closed simultaneously herewith.

THIS INSTRUMENT IS EXECUTED AS REQUIRED BY THE ARTICLES OF ORGANIZATION AND OPERATIONAL AGREEMENT OF GNC, LLC AND SAME HAVE NOT BEEN MODIFIED OR AMENDED.

ALL OF THE ABOVE PROCEEDS WERE PAID PURSUANT TO A MORTGAGE LOAN CLOSED SIMULTANEOUSLY HEREWITH.

The above Property is conveyed subject to:

Grantee accepts the Property in its present "AS IS" condition.



For purposes of this paragraph, the term Grantor shall mean and refer to (i) the members, agents and employees of Grantor; and (ii) any successors and assigns of Grantor. This covenant and agreement shall run with the land conveyed hereby as against Grantee, and all persons, firms, trusts, partnerships, limited partnerships, corporations, or other entities holding under or through the Grantee.

TO HAVE AND TO HOLD unto the said Grantee, its successors and assigns, forever .

Grantor makes no warranty or covenant respecting the nature of the quality of the title to the property hereby conveyed other than that the Grantor has neither permitted nor suffered any lien, encumbrance or adverse claim to the property described herein since the date of acquisition thereof by the Grantor.




