VERIFIED CLAIM OF LIEN

Hinkle Metals & Supply, Co., Inc. a corporation qualified under the laws of the State of Alabama, by and through Holly Hinkle who has personal knowledge of the facts herein set forth, files this statement in writing, verified by her oath. Hinkle Metals & Supply, Co., Inc., claims a lien upon certain real property located at 509 Highway 119 South, Alabaster, AL 35007 and situated in Shelby County, Alabama, more particularly described as follows, to-wit:

A portion of the N1/2 of the SW ¼ of the NE ¼ of Section 2, Township 21 South, Range 3 West, described as follows: Begin at the Southwest corner of the N ½ of the SW ¼ of the NE ¼ of Section 2, Township 21 South, Range 3 West, and run Easterly along the South side of the said N ½ for 790.66 feet to the point of beginning; then continue along the last described course for 342.22 feet; thence turn an angle of 57 degrees 13 minutes 19 seconds to the left and run Northeasterly for 26.54 feet; thence turn an angle of 84 degrees 09 minutes 30 seconds to the left and run northwesterly for 894.71 feet; then turn an angle of 107 degrees 39 minutes 31 seconds to the left and run southwesterly for 244.52 feet; then turn an angle of 72 degrees 20 minutes 29 seconds to the left and run southeasterly for 292.51 feet; then turn an angle of 90 degrees 00 minutes to the right and run southeasterly for 7.00 feet; then turn an angle of 90 degrees 00 minutes to the left and run southeasterly for 263.34 feet back to the point of beginning.

This lien is claimed, separately and severally, as to the land, buildings and improvements thereon to the extent of the entire lot or parcel which is contained within a city or town. If said land is not within a city or town, this lien is claimed, separately and severally, as to the buildings and improvements located on the above-described real property, plus one (1) acre of land surrounding and contiguous thereto.

This lien is claimed on the above mentioned land, buildings and improvements to secure the indebtedness owed by ICAG in the amount of Forty Four Thousand, Seventeen Dollars and Seventy-one cents (\$44,017.71) said sum being due and owing after all credits have been given,

from the 21st day of December, 2005, and which sum, plus attorney fees and interest thereon, is presently due and unpaid.

This sum of money is due and owing for materials and labor supplied by Hinkle Metals & Supply, Co., Inc., said materials and labor being used for the construction of the buildings and improvements on the above-described real property.
