## SUBORDINATION AGREEMENT

THIS AGREEMENT is made and entered into on this day of February, 2006 by Wachovia Bank, NA (hereinafter referred to as "Wachovia") in favor of HMSV-USB Lending, LLCdba MortgageSouth a Partnership, its successors and assigns, as their interest may appear(hereinafter referred to as "Lender").
