ARTICLES OF ORGANIZATION

OF

AWW, L.L.C.

TO THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, Terrence D. Lach, acting as members of a limited liability company under the laws of Alabama, hereby adopt the following Articles of Organization for AWW, L.L.C. (hereinafter referred to as "the company"):

ARTICLE I

NAME OF COMPANY

The name of the Company shall be AWW, L.L.C.

ARTICLE II

PERIOD OF DURATION

The period of duration for the company shall be fifty (50) years unless terminated or extended by written Agreement of the members.

ARTICLE III

OBJECTS AND PURPOSES

The objects and purposes for which the company is organized are:

1. To manufacture, market, build, sell, construct, and re-manufacture all types of construction products, cabinets, furniture, storage facilities, shelves, shelving for residential and commercial use.
2. To transact any and all lawful business for which limited liability companies may be organized under the Alabama Limited Liability Company Act, as such Act may be amended from time to time.
3. To have and exercise all powers necessary or convenient to effect the above purposes.

The foregoing paragraphs of this Article III, and each phase thereof, shall be construed, in their broadest sense, as purposes and powers of the Company in addition to those powers specifically conferred upon the Company by law, and it is hereby expressly provided that the foregoing specific enumeration of purposes and powers shall not be held to limit or restrict in any manner the powers of the Company otherwise granted by law. Nothing herein contained, however, shall be construed as authorizing the Company to carry on the business of banking or that of a trust company, or the business of insurance.


