Know All Men by These Presents: That in consideration of **One hundred forty one thousand and no/100 (\$141,000.00)** to the undersigned grantor, a limited liability company, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **JEF Homes, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Timothy Williams and Kimberly Williams** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby** County, Alabama, to-wit:

Lot 14, according to the Survey of Ridgecrest Subdivision, Phase One, Sector One, as recorded in Map Book 34, Page 17, in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to mineral and mining rights if not owned by Grantor.
