POWER OF ATTORNEY

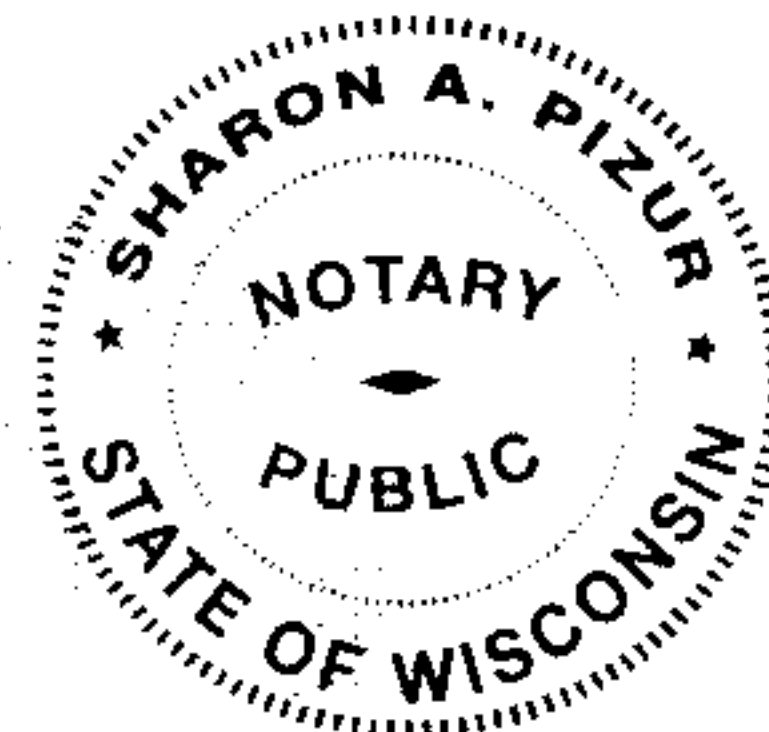
