

WARRANTY DEED
JOINT TENANTS WITH RIGHTS OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS, That, in consideration of **\$175,000.00** to the undersigned Grantor(s), **Anna Funderburk Buckner and James Randy Buckner Jr, a married couple**, in hand paid by the Grantees named herein, the receipt of which is hereby acknowledged, the said Grantor(s) does by these presents, grant, bargain, sell and convey unto **Galina Waites and David Waites** (herein referred to as "Grantees") the following described real estate, situated in Shelby County, Alabama, to-wit:
