

## WARRANTY DEED JOINT TENANTS WITH RIGHTS OF SURVIVORSHIP

## STATE OF ALABAMA COUNTY OF SHELBY

KNOW ALL MEN BY THESE PRESENTS, That, in consideration of \$175,000.00 to the undersigned Grantor(s), Anna Funderburk Buckner and James Randy Buckner Jr, a married couple, in hand paid by the Grantees named herein, the receipt of which is hereby acknowledged, the said Grantor(s) does by these presents, grant, bargain, sell and convey unto Galina Waites and David Waites (herein referred to as "Grantees") the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 28, according to the Greystone Farms Guilford Place, Sector 3, Phase 3, as recorded in Map Book 24, Page 27, in the Probate Office of Shelby County, Alabama.
