KNOW ALL MEN BY THESE PRESENTS, That whereas heretofore on to-wit: the 2nd day of May, 1997, Sheryl Ann Esdale, an unmarried woman, executed a certain mortgage on the property hereinafter described to SouthTrust Mortgage Corporation as recorded in Instrument No. 1997/14712 in the Probate Office of Shelby County, Alabama.

WHEREAS, default was made in the payment of the indebtedness secured by said mortgage, and the said SouthTrust Mortgage Corporation did declare all of the indebtedness secured by said mortgage due and payable and said mortgage subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage by publication in the Shelby County Reporter, a newspaper published in Shelby County, Alabama, and of general circulation in Shelby County, Alabama, in its issues of March 8, 15 and 22, 2006; and

WHEREAS, on the 31st day of March, 2006, the day on which the foreclosure was due to be held under the terms of said notice, between legal hours of sale, said foreclosure was duly and properly conducted, and SouthTrust Mortgage Corporation did offer for sale and sell at public outcry in front of the Courthouse at Shelby County, Alabama, the property hereinafter described; and

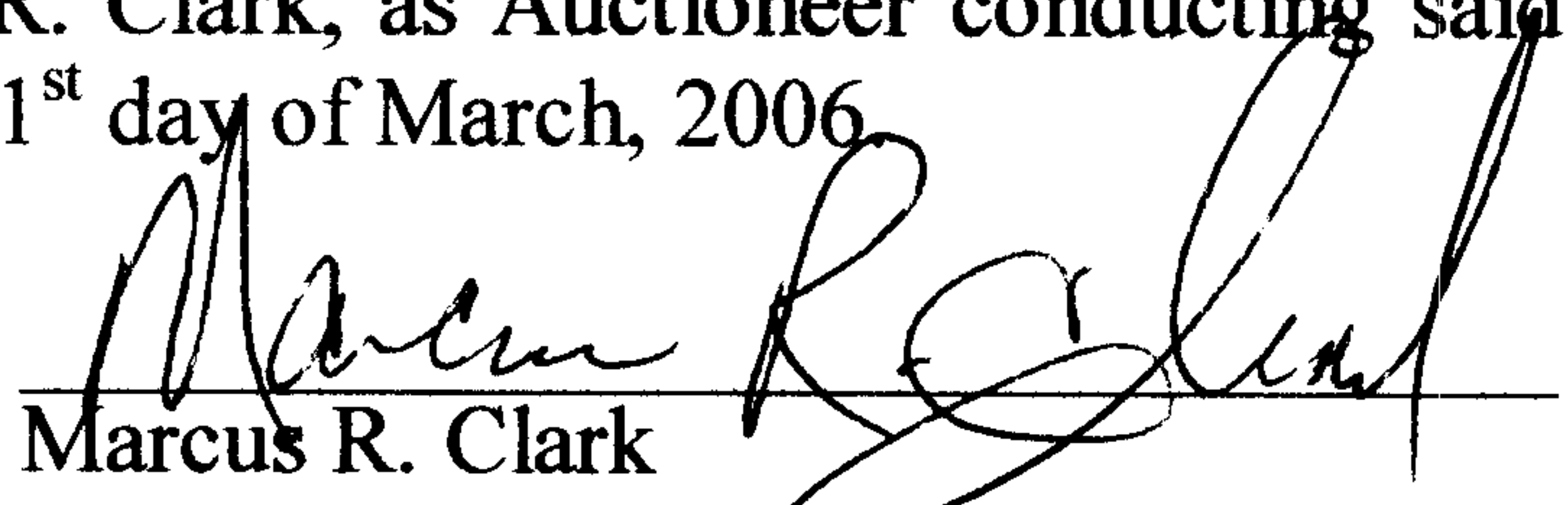

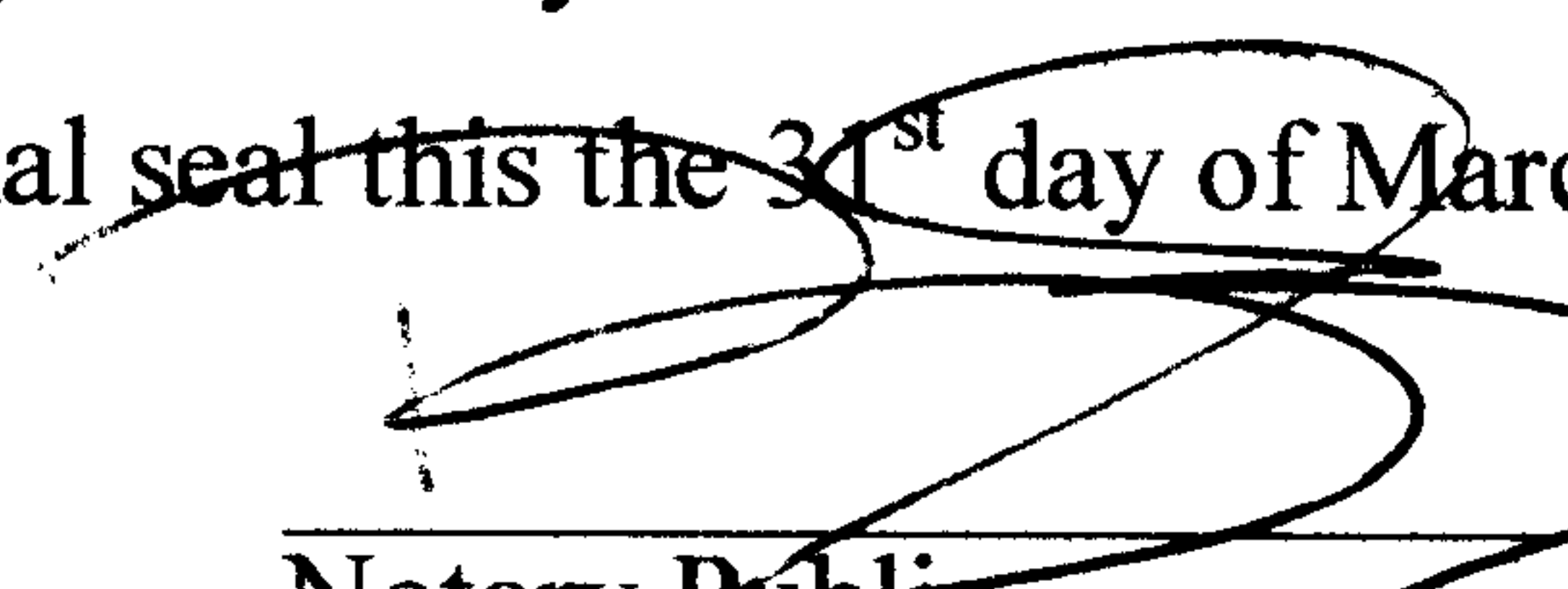
