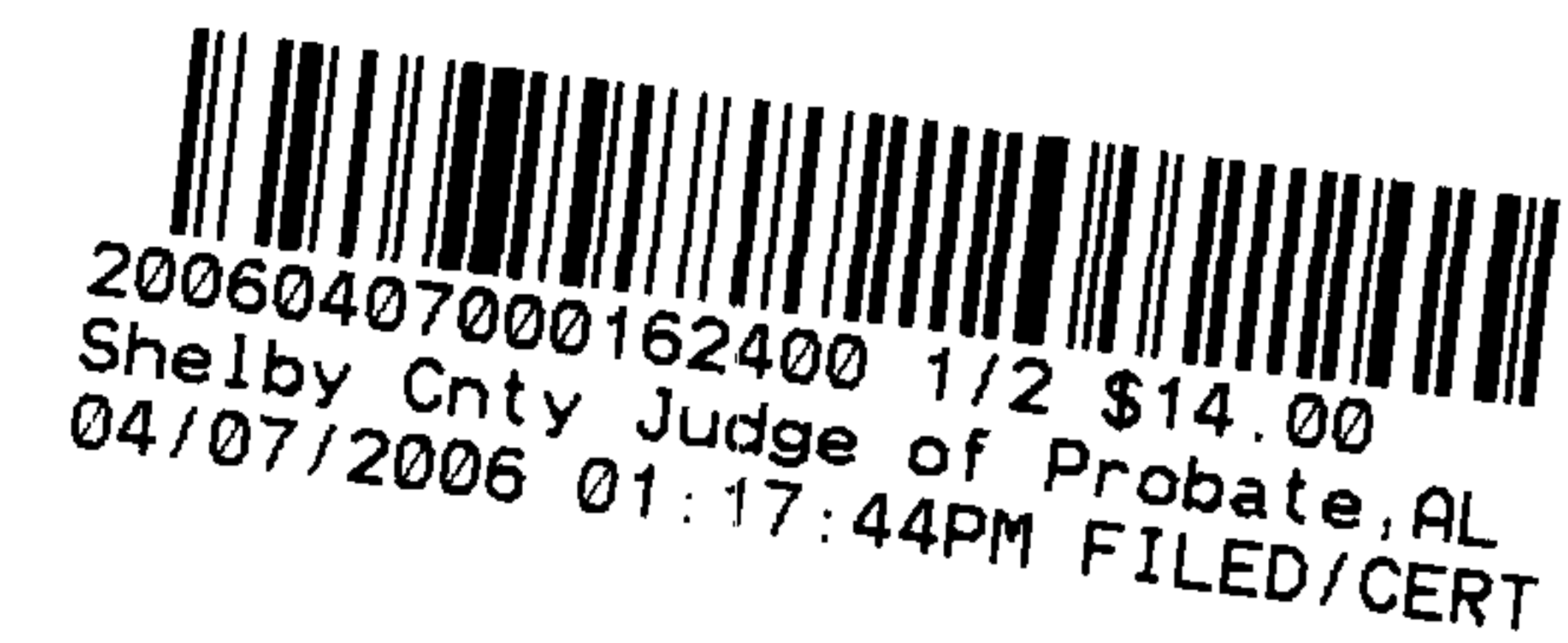

DURABLE POWER OF ATTORNEY

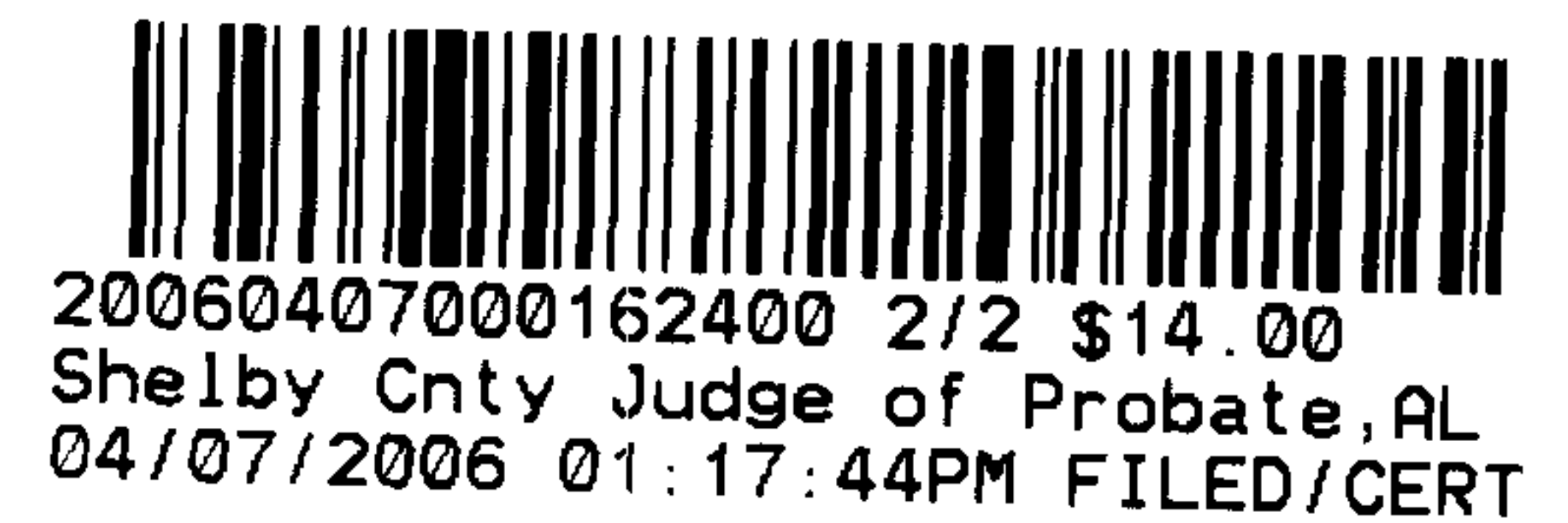
