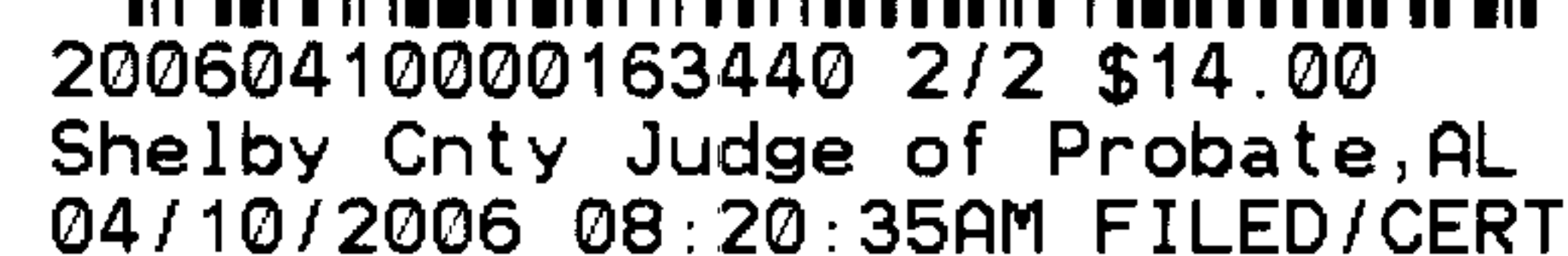
1. That I am over 21 years of age, and competent to give this affidavit.


