Know All Men by These Presents: That in consideration of **Two hundred ninety thousand and no/100 (\$290,000.00)** to the undersigned grantor, a limited liability company, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Donovan Builders, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Cheryl D. Martin and Carl E. Martin** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby** County, Alabama, to-wit:

Lot 124, according to the Final Plat Long Branch Estates, Phase I, as recorded in Map Book 34, Page 66, in the Probate Office of Shelby County, Alabama.

Subject to mineral and mining rights if not owned by Grantor.
