AMENDMENT TO THE ARTICLES

OF ORGANIZATION OF ARCHSECURE, LLC

Pursuant to the provisions of Section 10-12-11 of the <u>Code of Alabama</u>, the undersigned Limited Liability Company adopts the following Articles of Amendment to its Articles of Organization, effective as of the 10 day of April, 2006.

FIRST: The present name of the Limited Liability Company is EIA ASSOCIATES, LLC.

SECOND: The date of the filing of the original Articles of Organization was the 3rd day of November, 2003 in the office of the Judge of Probate, Shelby County, in Document Number 20031103000729050. The date of the filing of the First Amendment to the Articles of Organization was the 1st day of June, 2005 in the office of the Judge of Probate, Shelby County, in Document Number 20050714000352780.

THIRD: The Articles of Organization are hereby amended in their entirety so that as amended they read in full as follows:

ARTICLE I

NAME

The name of the Limited Liability Company shall be ArchSecure, LLC. ("the Company").

ARTICLE II

PERIOD OF DURATION


The term for which the Company is to exist as a Limited Liability Company shall commence on the date the original Articles of Organization are filed in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue until the Company shall be dissolved: (a) upon the written consent of all of the Members; (b) as provided in the Operating Agreement; (c) as may be required by the Alabama Limited Liability Company Act, as the same may be amended from time to time; or (d) by any other act or event specified by law as one effecting dissolution.

ARTICLE III

PURPOSE

The Company is formed to transact any and all lawful business for which a Limited Liability Company made be organized under the Alabama Limited Liability Company Act, including, but not limited to

- (a) To develop, maintain and market computer technology solutions that securely transfer information between enterprises;
- (b) Acquiring, owning, operating, managing, mortgaging, encumbering, selling, exchanging, otherwise disposing of and/or dealing with businesses and investments for the production of income and profit;
- (c) Acquiring, owning, buying, selling, investing in, managing, financing, refinancing, exchanging, otherwise disposing of and/or dealing with stocks, securities, partnership interests, limited liability company interests, certificates of deposit, mutual funds,



- commodities, and any and all whatsoever, that the Managers may from time to time deem to be in the best interests of the Company; and
- (d) Engaging in any and all activities related or incidental to the foregoing business of the Company.

ARTICLE IV

LOCATION OF REGISTERED OFFICE AND NAME OF REGISTERED AGENT

The initial registered office of the Company shall be at 3018 Piper Way, Hoover, Alabama 35244, and the name of the initial registered agent at such address shall be **John M. Walker.**

The Operating Agreement of the Company shall be executed by each Member of the Company and

shall set forth all provisions for the affairs of the Company and the conduct of its business to the extent that

such provisions are not inconsistent with law or these Articles.

ARTICLE VIII

CONTINUATION UPON WITHDRAWAL OF MEMBER

The Members shall have the right to continue the Company upon the death, retirement, resignation,

expulsion, withdrawal, bankruptcy or dissolution of a Member or occurrence of any event which terminates

the continued membership of a Member in the Company (collectively, "Cessation") as long as there is at

least one remaining Member or after the Cessation of the last Member, one or more new members are

appointed as set forth in the Operating Agreement of the Company.

ARTICLE IX

LIABILITIES OF MEMBERS AND MANAGERS

The Members and the Manager of the Company are not liable under a judgment, decree or order of

a court, or in any other manner, for a debt, obligation or liability of the Company.

MANAGERS




