## POWER OF ATTORNEY

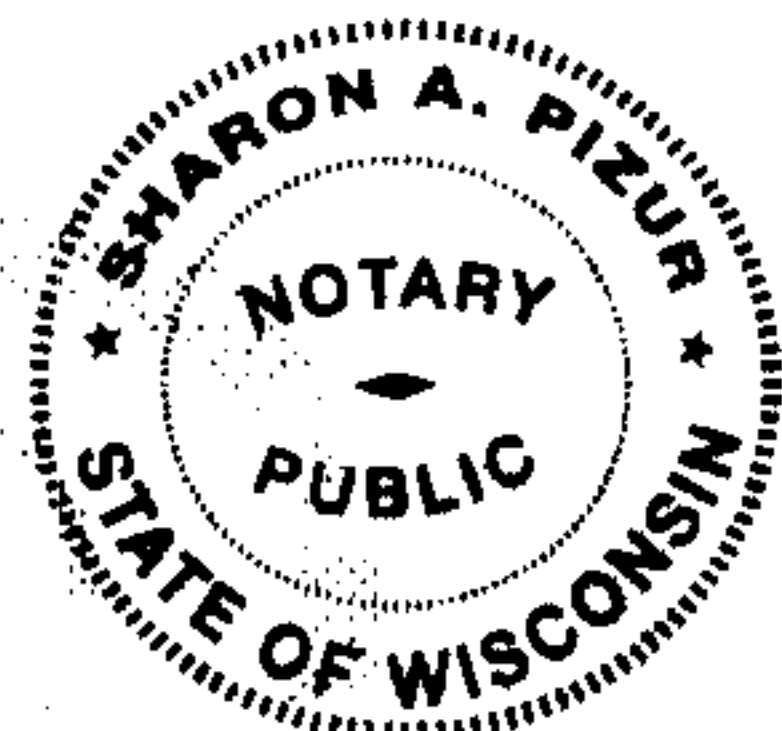
