ORDER ON MOTION TO TRANSFER LIENS

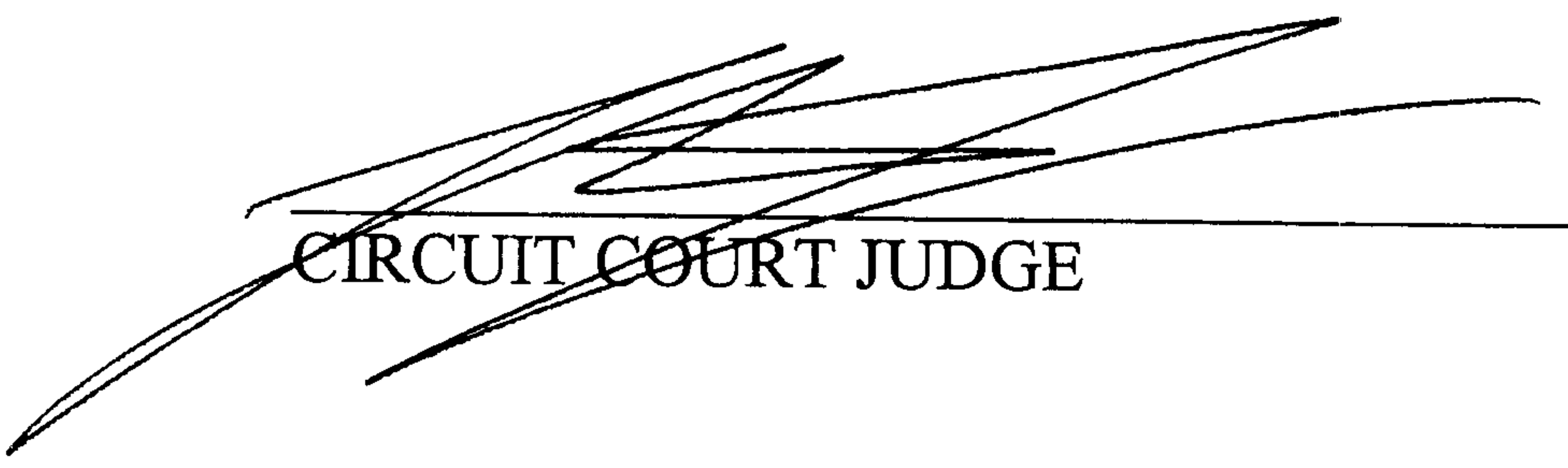
