

FIRST AMENDMENT TO ARTICLES OF INCORPORATION OF THE AMMERSEE LAKES PROPERTY OWNERS ASSOCIATION

Articles III, <u>Purposes and Powers</u> and Article IV, <u>Members</u>, of the Articles of Incorporation of The Ammersee Lakes Property Owners Association is hereby amended by with the following changes, substitutions, deletions and/or additions to Sections 3.5 and 4.1.

PROPOSED AMENDMENTS

It is approved by a 70% vote that Aricle III, <u>Purposes and Powers</u>, Section 3.5, be amended to read as follows:

As used in the Articles of Incorporation, the term "Lot" shall include any Improved Lot that is at the time of the execution hereof described in the Ammersee Lakes Subdivision, First Sector recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Map Book 28, Page 98 A & B, Second Sector to be recorded in said Probate Office. The term "Improved Lot" shall mean any Lot (a) on which there is at the time located any building or (b) on which a permit for the erection of a building has theretofore been issued by a governmental authority having jurisdiciton.


It is approved by a 70% vote that Article IV, <u>Members</u>, Section 4.1, be amended to read as follows:

4.1 Each owner of record fee simple title to an Improved Lot shall be a dues paying member of the Association. Each Improved Lot shall be entitled to one vote which may be cast by the owner or the owner's spouse or by a lawful proxy as provided in the by-laws. If an Improved Lot is owned by more than one person or entity, the vote for such Improved Lot shall be exercised as they determine between or among themselves, but in no event shall more than one (1) vote be cast with respect to each Improved Lot. If any member shall cease to be the owner of an Improved Lot, such member's membership shall automatically pass to such member's successor in title.

The within Amendments have been adopted by a consent in writing, signed by 70% of all members of The Ammersee Lakes Property Owners Association as required by the Articles of Incorporation recorded in Instrument #20020923000459660 in the Office of the Judge of Probate of Shelby County, Alabama.


