ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION GUIDELINES

Pursuant to the provisions of the Alabama Nonprofit Corporation Act, the undersigned hereby adopts the following Articles of Amendment.

Article I

The name of the corporation: Healing Waters Church, Inc.

Article II

The following amendment was adopted:

- a. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- b. Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3 of the Internal Revenue Code, or shall distributed to the federal government, or state or local government, for public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.

Article III

The date of the meeting of the members where the amendment was adopted, a quorum was present, and the amendment received at least two-thirds of the vote entitled to be cast: March 13, 2006


