


ARTICLES OF ORGANIZATION OF B&C PROPERTIES, LLC AN ALABAMA LIMITED LIABILITY COMPANY

ARTICLES OF ORGANIZATION

ARTICLE I NAME

The name of the limited liability company (the "Company") is:


B&C PROPERTIES, LLC,

ARTICLE II DURATION

ARTICLE V INITIAL MEMBERS


