STIPULATION OF INTEREST AND CROSS-CONVEYANCE

(The lands described herein do not constitute any part of the homestead of the parties herein or their spouse)




amount and nature of interests owned by each of us in the property described hereinabove are as follows:

This Stipulation and Cross-Conveyance shall be binding upon the parties hereto, their


