

**ARTICLES OF INCORPORATION**  
**OF**  
**ALABASTER CHURCH OF GOD IN CHRIST**  
**(a nonprofit corporation)**

Pursuant to the provisions of the Alabama Nonprofit Corporation Act, the undersigned hereby adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of the corporation is Alabaster Church of God in Christ.

**ARTICLE II**

**DURATION**

The corporation shall have perpetual duration.

**ARTICLE III**

**PURPOSES**

The corporation has been organized for the following purposes: exclusively for charitable, religious, including the operation of a church, education, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code.

**ARTICLE IV**

**MEMBERS**

The corporation shall have no members.

## **ARTICLE V**

### **REGISTERED OFFICE/AGENT**

The location and street address of the initial registered office of the corporation shall be 956 2<sup>nd</sup> Avenue NW, Alabaster, Alabama 35007, and the name of its initial registered agent at such address shall be Arnita or Lloyd King.

## **ARTICLE VI**

### **BOARD OF DIRECTORS**

The number of directors shall be three (3). The names and addresses of the members of the initial Board of Directors are:

## **ARTICLE VIII**

### **INTERNAL REVENUE CODE PROVISIONS**


**A.** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code.

**B.** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
