Our Agent shall have full power and authority to act on my behalf, but only to the extent permitted by this Special Power of Attorney. My Agent's powers shall include the power to:



Our Agent shall be entitled to reimbursement of all reasonable expenses incurred in connection with this Special Power of Attorney, and shall be entitled to any reasonable compensation for carrying out the powers of this instrument, if such compensation results from the Agent having to taking leave from employment to exercise the powers in this Special Power of Attorney.
