

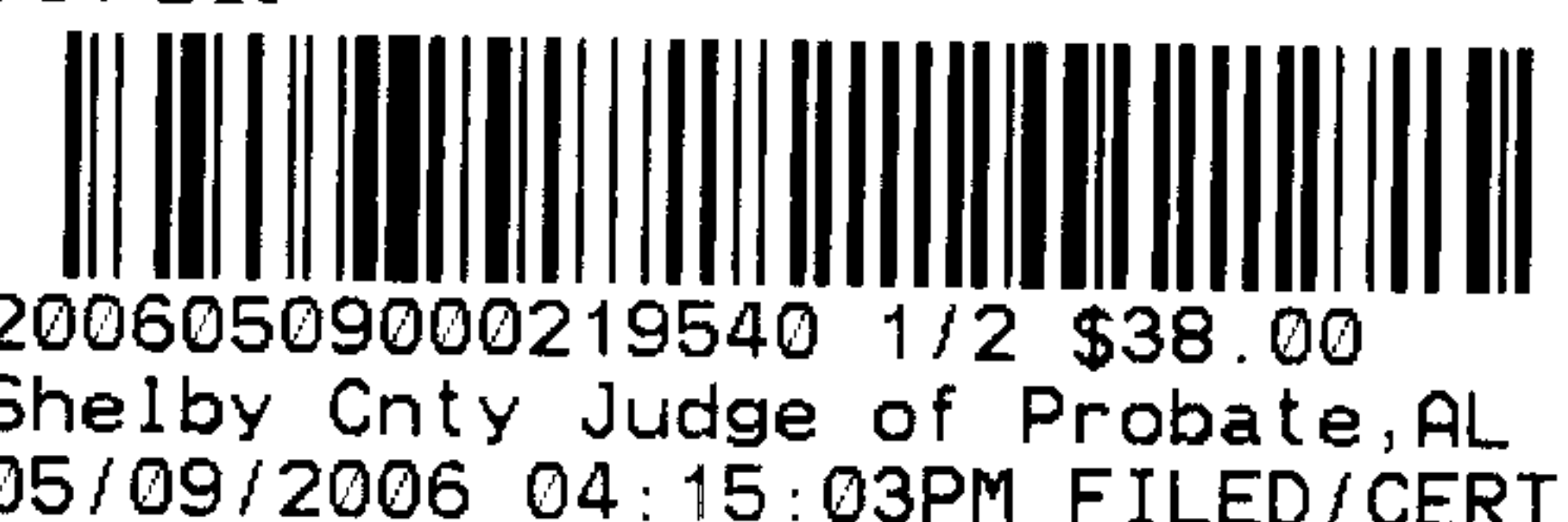

That in consideration of **Two Hundred Thirty Six Thousand Nine Hundred and No/100-----Dollars (\$236,900.00)**, to the undersigned grantor, **NOEL DEVELOPMENT CORP.**, a corporation, (herein referred to as **GRANTOR**), in hand paid by the **GRANTEES** herein, the receipt of which is hereby acknowledged, the said **GRANTOR** does by these presents, grant, bargain sell and convey unto **RICHARD LINDELL and wife, EVETTE LINDELL**,(herein referred to as **GRANTEES**), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, described as follows:




