

## EXHIBIT "A"

A parcel of land in the Northeast 1/4 of the Northwest 1/4 and the Northwest 1/4 of the Northeast 1/4 of Section 18, Township 21 South, Range 2 West, Shelby County, Alabama, more particularly described as follows:

Commence at the Northwest corner of Section 18, Township 21 South, Range 2 West; thence South 89 degrees 06 minutes 53 seconds East and run along the North line of said Section a distance of 2,015.04 feet to the Northeasterly right of way line of L & N North bound tract (100 foot right of way); thence continue along the last described course and run a distance of 480.43 feet to the Southwesterly right of way line of U.S. Highway No. 31 (200 foot right of way); thence South 39 degrees 16 minutes 16 seconds East and along said right of way run a distance of 202.22 feet to the intersection with the Southwesterly right of way line of said U.S. Highway No. 31 and the centerline of Buck Creek, said point being the point of beginning; thence continue along the last described course a distance of 306.85 feet; thence North 77 degrees 13 minutes 37 seconds West and leaving said right of way run a distance of 135.36 feet; thence South 02 degrees 03 minutes 25 seconds East and run a distance of 343.14 feet to the Northeasterly right of way of said L & N North bound tract; thence North 43 degrees 42 minutes 17 seconds West and along said right of way run a distance of 771.36 feet; thence South 89 degrees 06 minutes 53 seconds East and leaving said right of way a distance of 453.48 feet to the point of beginning.
