Know All Men by These Presents: That in consideration of **Ten thousand and no/100 (\$10,000.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Donna Leslie f/k/a Donna Butler and Charles J. Leslie, Sr., wife and husband** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Donna M. Leslie and Charles J. Donna Butler and Donna Leslie are one and the same person.






