KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 1st day of May, 2004, Hortense B. Henderson, married and wife, Cassaundra L. 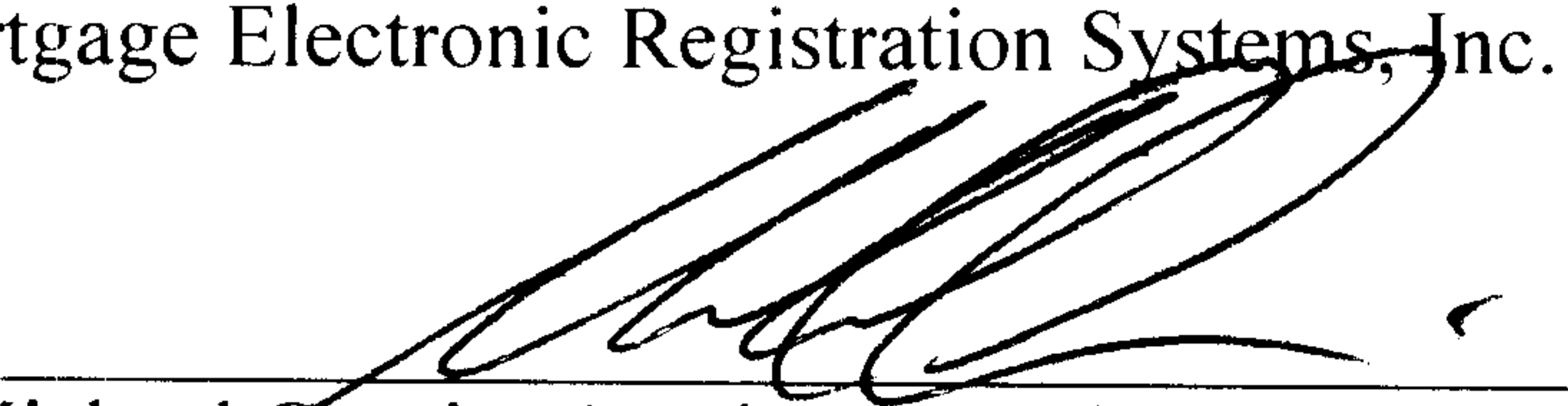
