

### ARTICLES OF ORGANIZATION

Pursuant to the Alabama Limited Liability Company Act (The "Act"), the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

### ARTICLE I NAME

The name of the limited liability company (the "Company") is:



# ARTICLE II DURATION

The existence of the Company shall be perpetual, or until terminated by agreement of the member or members or by operation of law.

# ARTICLE III PURPOSES

necessary, proper, advisable or convenient in connection with same, and to do all other things incidental to such purposes or in connection with such purposes that are not prohibited by law. In extension and not in limitation of the purposes specifically enumerated, the Company is authorized and empowered to engage in any lawful business in which limited liability companies may engage under the Act.

# ARTICLE IV INITIAL REGISTERED OFFICE AND AGENT

The location and mailing address of the initial registered office of the Company is 120 Carriage Drive, Maylene, Alabama 35114. The name of the initial registered agent for the Company is Deninson Torrealba.


# ARTICLE V INITIAL MEMBER

Any amendment to these Articles of Organization shall require approval of all of the members.
