CONSENT JUDGMENT

At the request of the parties it is hereby ORDERED, ADJUDGED, and DECREED as follows:

1. This Court has jurisdiction over this matter pursuant to 28 U.S.C. §1334, 28 U.S.C. §157(a), and the Order of Reference entered by the District Court.
2. Venue is proper in this district by virtue of 28 U.S.C. §1409(a), as this proceeding arises in and relates to a case under the Bankruptcy Code that is pending in this district.
3. This is a core proceeding pursuant to 28 U.S.C. §157(b)(2)(I).
4. This is an adversary proceeding pursuant to Fed. R. Bankr. P. 7001(6).
5. Judgment is hereby rendered in favor of Plaintiff and against Defendant, David A. Cooper, for the principal sum of \$10,000.00 (hereinafter "Judgment").
6. The Judgment is non-dischargeable pursuant to 11 U.S.C. §523(a)(6).
7. Interest shall accrue upon said Judgment at 0% per annum, until paid in full.
8. The Judgment is rendered against Defendant without waiver of exemptions.

9. With the exception of the recording of a certificate of judgment, the Plaintiff shall be stayed from garnishment or execution upon this Judgment so long as Defendant shall pay to the order of Plaintiff, in presently available funds, the sum of \$166.66 per month, beginning the 1st day of the calendar month following sixty (60) days after the closing of this Chapter 7 case but not later than August 1, 2006, and on or before the 1st day of each consecutive month thereafter for a total of sixty (60) months until the full principal amount of \$10,000.00 is paid in full. Upon timely payment of all sixty (60) monthly payments as specified herein, the Judgment shall be deemed "paid in full." However, in the event Defendant fails to pay any payment within ten (10) days of the due date (hereinafter "Default"), said stay of execution and garnishment shall be automatically lifted without further order of this Court, and all payments received by Plaintiff from Defendant shall be applied first to interest accruing upon the Judgment and secondly to the principal amount of said Judgment. Further, upon Default, the original Judgment, together with interest as provided herein, shall then remain in full force and effect until all principal, interest and court costs are paid in full.
10. All payments are to be mailed directly to H. Spence Morano, as attorney for Ogletree Plaza, LLC, whose address is P.O. Box 43219, Birmingham, Alabama 35243.
11. Costs are hereby taxed to the Defendant.
