KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 4th day of August, 2004, April Parker, a married woman and husband, Mike Parker, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for MortgageAmerica, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument #20040811000449890, said mortgage having subsequently been transferred and assigned to Countrywide Home Loans, Inc., by instrument recorded in, in the aforesaid Probate Office; and


