

SCHEDULE I TO FINANCING STATEMENT

This financing statement covers the following items (or types) of property:

- (a) <u>Land</u>. The land located in Shelby County, Alabama more particularly described in <u>Exhibit A</u>, and all reversions and remainders in and to said land and all tenements, hereditaments, easements, rights-of-way, rights (including mineral and mining rights, and all water, oil and gas rights), privileges, royalties and appurtenances to said land, now or hereafter belonging or in anywise appertaining thereto, including any right, title and interest in, to or under any agreement or right granting, conveying or creating, for the benefit of said land, any easement, right or license in any other property, and in, to or under any streets, ways, alleys, vaults, gores or strips of land adjoining said land or any parcel thereof, or in or to the air space over said land; all rights of ingress and egress to parking facilities on or within said land; and all claims or demands of Borrower either at law or in equity, in possession or expectancy of, in or to any of the same (all of the foregoing hereinafter collectively called the "<u>Land</u>").
- (b) <u>Improvements</u>. All buildings, structures, facilities and other improvements now or hereafter located on the Land, and all building materials, building equipment and fixtures of every kind and nature now or hereafter located on the Land or attached to, contained in, or used in connection with, any such buildings, structures, facilities or other improvements, and all appurtenances and additions thereto and betterments, renewals, substitutions and replacements thereof, now owned or hereafter acquired by the Borrower (all of the foregoing hereinafter collectively called the "<u>Improvements</u>," and together with the Land called the "<u>Real Property</u>").
- (c) <u>Personal Property</u>. All goods, equipment, inventory, supplies and other items or types of tangible personal property (including additions and accessions thereto and replacements and substitutions therefor) now owned or hereafter created or acquired by the Borrower and attached to the Real Property (other than fixtures); or placed on the Real Property and used or useful in connection with, or in any way pertaining or relating to, the Real Property or the use and occupancy thereof, though not attached to the Real Property; or for which the proceeds of any credit secured by this financing statement have been or may be advanced, wherever the same may be located (hereinafter collectively called the "<u>Personal Property</u>").
- (d) <u>Rents and Leases</u>. All leases, subleases, lettings and licenses, and other use and occupancy agreements, now or hereafter pertaining to any of the Real Property or Personal Property, and all rents, profits, issues and revenues of the Real Property and Personal Property now or hereafter accruing, whether accruing before or after the filing of any petition by or against the Borrower under the federal Bankruptcy Code.
- (e) <u>Insurance Policies</u>. All policies of hazard insurance now or hereafter in effect that insure the Improvements, the Personal Property, or any of the other property conveyed or

encumbered by the mortgage to which this financing statement relates (the "Mortgage"), together with all right, title and interest of the Borrower in and to each and every such policy, and all proceeds thereof, including any premiums paid and rights to returned premiums.


- Litigation Awards. All judgments, damages, settlements, awards, payments and compensation, including all interest thereon, together with the right to receive the same, that may be made or due to the Borrower or any subsequent owner of any of the Real Property, the Personal Property or any other property conveyed or encumbered by the Mortgage, as a result of the exercise of the right of eminent domain or condemnation, the alteration of the grade of any street or any other injury to or diminution or decrease in value of the Real Property, the Personal Property or any other such property.
- General Intangibles and Agreements. (a) All general intangibles relating to the development or use of the Real Property, the Personal Property or any other property conveyed or encumbered hereby, or the management and operation of any business of the Borrower thereon, including all patents, patent applications, trade names, trademarks, trademark applications, knowledge and process, licensing arrangements, blueprints, technical specifications, manuals and other trade secrets; (b) the good will of any business conducted or operated on the Real Property, all governmental licenses and permits relating to the construction, renovation or operation thereof, all names under or by which the same may at any time be operated or known and all rights to carry on business under any such names or any variant thereof; (c) all contracts and agreements (including leasing, construction, renovation, maintenance, engineering, architectural, management, operating and concession agreements) affecting the Real Property, the Personal Property or any other property conveyed or encumbered by the Mortgage, or used or useful in connection therewith, whether now or hereafter entered into; and (d) all rights (special or otherwise), title and interest of the Borrower as the Developer or Owner (as such terms are defined in the Declaration) under the Declaration (as defined in the Mortgage) or any other condominium regime documents to which the Property or any part thereof may at any time be subject, and all rights of the Borrower, as Developer or Owner or otherwise, to amend or modify the Declaration or any other condominium regime documents to which the Property or any part thereof may at any time be subject, or otherwise with respect to the Property or any thereof, all right, title and interest of the Borrower in and to each and every contract or agreement, now existing or hereafter entered into, for the sale of Condominium Units (as defined in the Mortgage), all escrow deposits (or letters of credit issued in lieu thereof) with respect thereto (to the extent of Borrower's right to create a security interest therein), and all tax, insurance and other escrows; provided, however, that, notwithstanding anything to the contrary contained herein, this Agreement shall not assign and transfer to the Lender, or create a security interest in favor of the Lender in, the right, title and interest of the Borrower in any permit issued by a Governmental Authority in connection with the Property that by its terms is not transferable or the transfer of which is conditioned upon the consent or approval of the issuing Governmental Authority or might have a material adverse affect on the Property (a "Restricted Permit"), except to the extent and only to the extent that the right, title and interest of the Borrower in such Restricted Permit may be so transferred and assigned to the Lender, and a security interest in favor of the Lender created therein, without violating the provisions of the Restricted Permit or otherwise materially adversely affecting such right, title and interest of the Borrower in the Restricted Permit or the Property.

- (h) <u>Supplemental Documents</u>. All changes, additions, supplements, modifications, amendments, extensions, renewals, revisions and guaranties to, of or for any agreement or instrument included in the foregoing.
 - (i) Proceeds. All proceeds of any of the foregoing.

As used in this Schedule I, Borrower means the debtor(s) described in this financing statement.

Some of the above-described property is now, or may in the future become, affixed to the Land described in Exhibit A. The Borrower is a record owner of the Land.

SCHEDULE II TO FINANCING STATEMENT

This financing statement covers the following items (or types) of property:

- (a) All leases and subleases, written or oral, and all agreements for use or occupancy of any portion of the land described on Exhibit A attached hereto and made a part hereof (the "Land") or any improvements, buildings, structures and fixtures now or hereafter located thereon (the "Improvements") with respect to which the Borrower is the lessor or sublessor, including the existing leases, if any, described on Exhibit B attached hereto and made a part hereof (the "Existing Leases"), any and all extensions and renewals of said leases and agreements and any and all further leases or agreements, now existing or hereafter made, including subleases thereunder, upon or covering the use or occupancy of all or any part of the Land or the Improvements, all such leases, subleases, agreements and tenancies heretofore mentioned (including the Existing Leases), whether entered into before or after the filing by or against the Borrower of any petition for relief under the federal Bankruptcy Code, being covered by this assignment and being hereinafter collectively referred to as the "Leases";
- (b) any and all guaranties of the lessee's and any sublessee's performance under any of the Leases;
- (c) the immediate and continuing right to collect and receive all of the rents, income, receipts, revenues, issues and profits now due or which may become due or to which the Borrower may now or shall hereafter (including during the period of redemption, if any) become entitled or may demand or claim, whether paid or accruing before or after the filing of any petition by or against the Borrower for relief under the federal Bankruptcy Code, arising or issuing from or out of the Leases or from or out of the Land or the Improvements, or any part thereof, including minimum rents, additional rents, percentage rents, common area maintenance charges, parking charges, tax and insurance premium contributions, and liquidated damages following default, the premium payable by any lessee upon the exercise of any cancellation privilege provided for in any of the Leases, and all proceeds payable under any policy of insurance covering loss of rents resulting from untenantability caused by destruction or damage to the Land or the Improvements, together with any and all rights and claims that the Borrower may now or hereafter have against any such lessee under the Leases or against any subtenants or occupants of the Land or any of the Improvements; and
- (d) any award, dividend or other payment made hereafter to the Borrower in any court procedure involving any of the lessees under the Leases in any bankruptcy, insolvency or reorganization proceedings in any state or federal court and any and all payments made by lessees in lieu of rent.




EXHIBIT A TO FINANCING STATEMENT

(Real Estate Description)

Begin at the SW corner of the NE 1/4 of the SE 1/4 of Section 5, Township 22 South, Range 2 West; thence run North 0°50'21" West along the West line thereof for 1383.79 feet to an iron pipe; thence South 88°15'55" East run along a fence for 1200.14 feet to a 1" bolt and fence corner; thence South 87°32'26" East along a fence for 1053.28 feet to a 1/2" capped rebar; thence North 7°35'49" West for 311.49 feet to the Southerly R/W of I-65; thence South 52°51'29" East along said R/W for 352.16 feet to the Westerly R/W of C.S.X. Railroad; thence South 7°36'18" East run along said R/W for 1015.05 feet to a curve to the right (having a radius of 714.07 feet, and a central angle of 38°00'06"); thence run Southerly along said curve and R/W for 473.61 feet to the South line of last said 1/4 - 1/4 section; thence North 88°52'13" West for 1196.71 feet to a 1" pipe; thence North 88°14'53" West for 1318.04 feet to the point of beginning.

An easement over and across the hereinafter described property for the installation and maintenance of a water line, which said property an easement is more particularly described as follows:

Commence at the SW corner of the NW 1/4 of the SW 1/4 of Section 4, Township 22 South, Range 2 West; thence run Easterly along the South line thereof for 8.0 feet to the point of beginning; thence 90°00' right run Southerly 24.20 feet to the Northerly R/W of Shelby County Road #84; thence 88°33' left run Easterly along said R/W for 6.0 feet; thence 91°30' left run Northerly 24.35 feet to the South line of said 1/4 - 1/4 section; thence 90°00' left run Westerly 6.0 feet to the point of beginning.

A 60 foot easement for ingress and egress described as follows:

Commence at the SW corner of the NW 1/4 of the SW 1/4 of Section 4, Township 22 South, Range 2 West; thence South 88°52'13" East for 775.11 feet to the point of beginning; thence 90°00' right for 63.18 feet to the Northerly R/W of Shelby County Road #84; thence 86°16'52" left run Easterly along said R/W for 60.13 feet; thence 93°43'17" left run Northerly 67.08 feet; thence 90°00' left run North 88°52'13" West for 60.0 feet to the point of beginning.

All being situated in Shelby County, Alabama.


