

ARTICLES OF INCORPORATION

The corporation is organized for the purpose of making and selling jewelry and the exercise of all powers now granted, or which in the future may be granted, by the Act to corporations formed thereunder, subject to any limitation imposed or any provision of any other statute of the State of Alabama, and for transacting any or all lawful business for which corporations may be incorporated under the Act.
