SHELBY COUNTY, ALABAMA

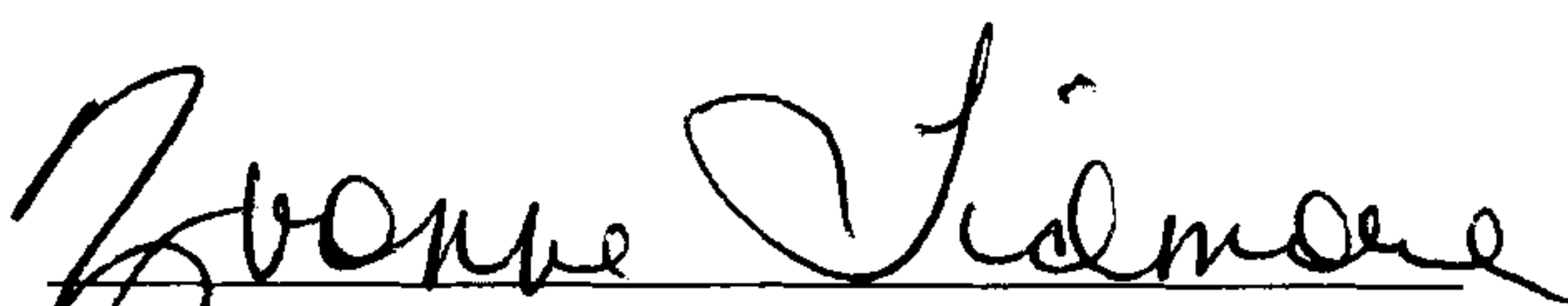

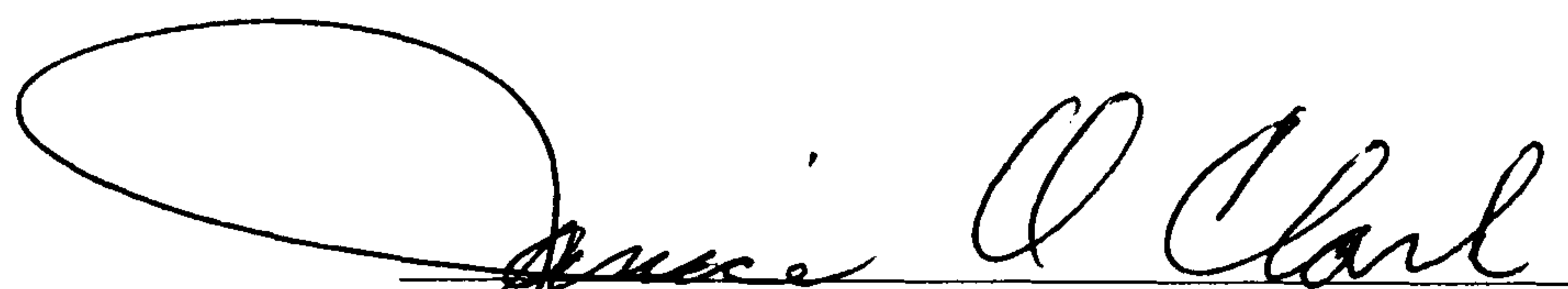

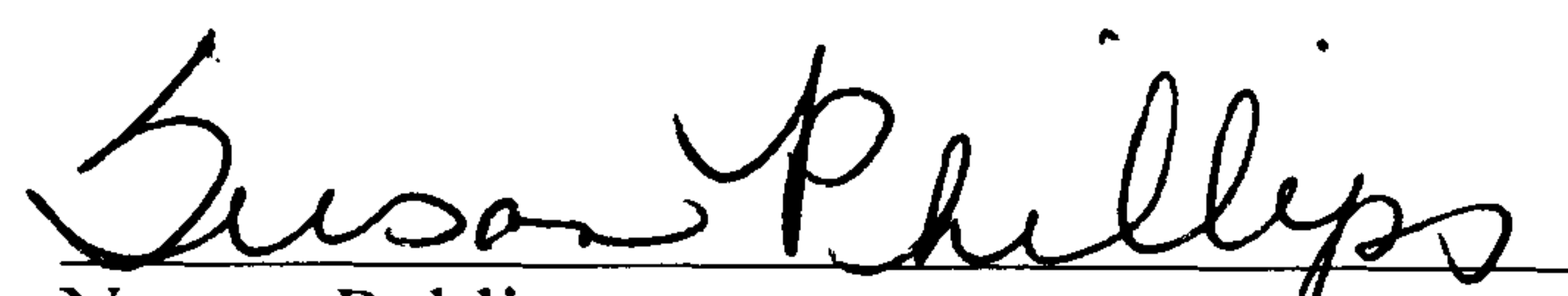
