FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of August 1997, Richard L. Tasich, an unmarried man, executed that certain mortgage on real property hereinafter described to Dime Mortgage, Inc. d/b/a National Mortgage Investments Co., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 1997-27920, corrected and re-recorded in Inst. No. 1998-09687, said mortgage having subsequently been transferred and assigned to DIME Savings Bank of New York, FSB, by instrument recorded in Instrument No. 1997-33330, in the aforesaid Probate Office; and

WHEREAS, default was made in the payment of the indebtedness secured by said mortgage, and the said Washington Mutual Bank, FA successor by merger to DIME Savings Bank of New York, FSB did declare all of the indebtedness secured by said mortgage subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage by publication in the Shelby County Reporter,

a newspaper of general circulation published in Shelby County, Alabama, in its issues of May 10, 2006, May 17, 2006, and May 24, 2006; and


WHEREAS, on June 6, 2006, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and Washington Mutual Bank, FA successor by merger to DIME Savings Bank of New York, FSB did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and


