Public during his/her continuance therein, then this obligation shall be null and void; otherwise, it shall remain in full force and effect.

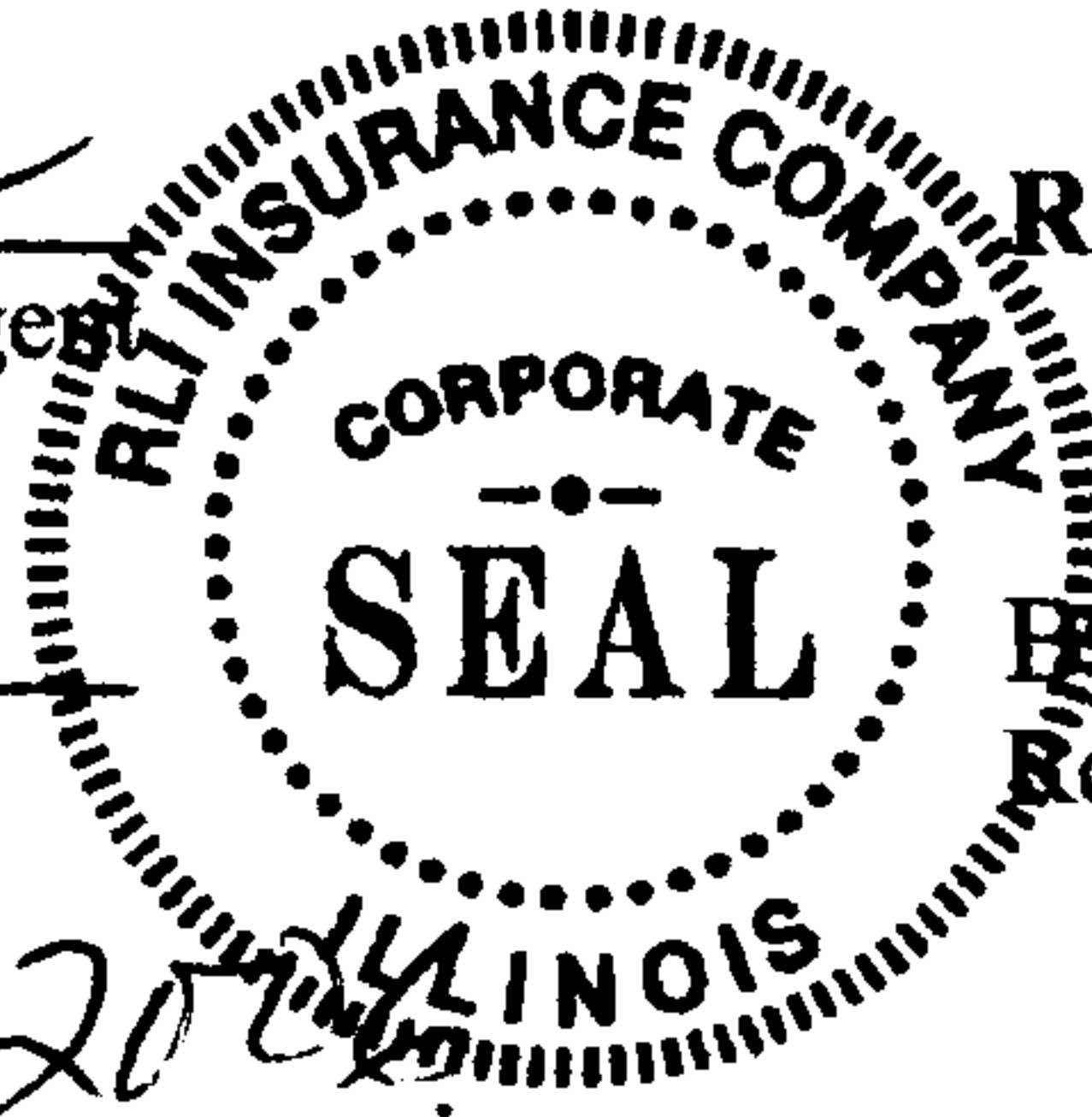

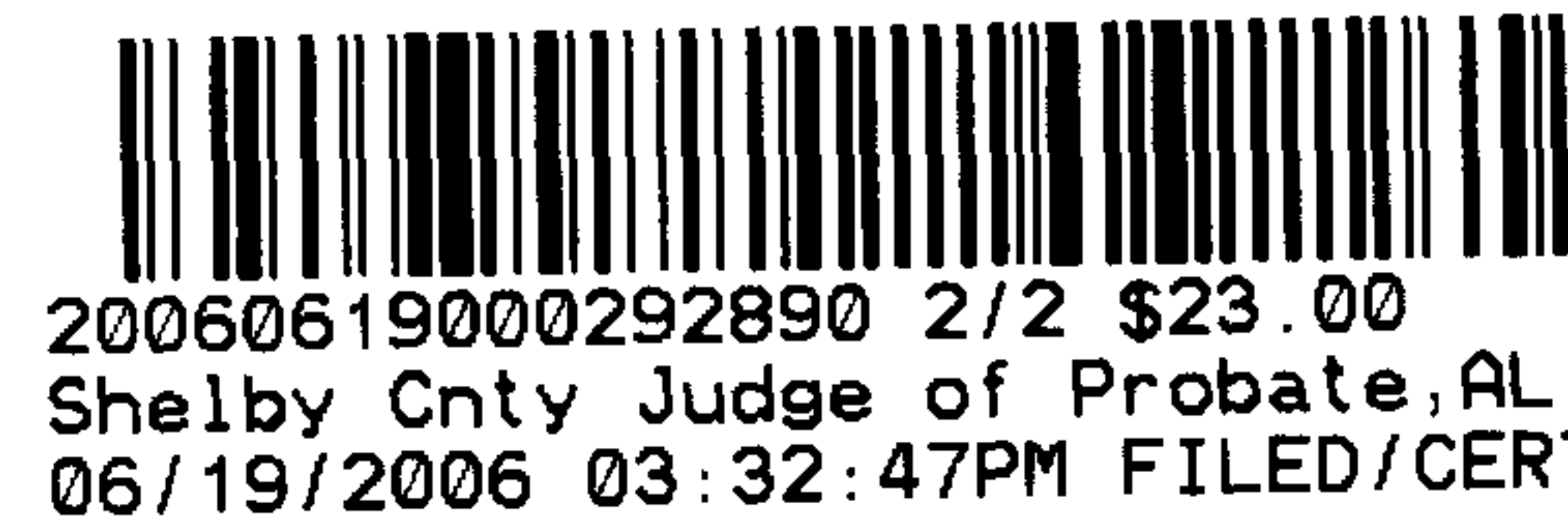
